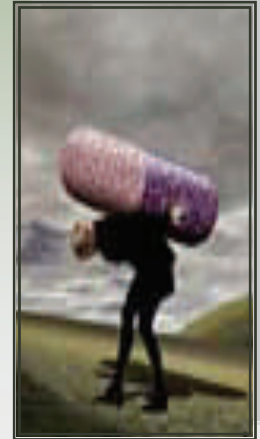

Many individuals and families without prescription coverage, limited prescription coverage or having a medical hardship have difficulty paying for their medications and don't know where to get help.

Through the existing Prescription Assistance Programs sponsored by the United States Pharmaceutical Companies, people can get access to more medications that treat a wide range of conditions including but not limited to, Diabetes, Cancer, Depression, Hypertension, High Cholesterol, ADHD, Asthma, HIV, Auto Immune Disorders.

Basic Eligibility Guidelines for Prescription Assistance Programs:

- Be a Citizen or Legal Resident of the United States
- Have no prescription or limited prescription coverage
- The applicants income must fall within the guidelines established by each program sponsor.

What are Prescription Assistance Programs?

All of the major Pharmaceutical Companies have medication assistance programs, although every company has different eligibility guidelines and application requirements. Individuals that meet the eligibility guidelines can receive assistance for both Name Brand and Generic medications. These program provide a variety of types of assistance:

- Free medicines to those who meet the income guidelines and are without prescription drug coverage.
- Prescription savings or discount programs for those without prescription drug coverage but are above the income eligibility guidelines.
- If you do not meet the income or prescription drug coverage criteria, but are experiencing significant financial and medical hardship. You may still qualify for assistance through the programs.

Other Programs Available

If we can not help you with medications through the Prescription Assistance Programs, or while your application is being processed, we offer a reduced cost prescription drug plan for savings on medications.
